The Mission of the Greater Kansas City Deafblind Task Force is to assist individuals with deafblindness and their families in achieving full access to the community through collaboration. The Greater Kansas City Deafblind Task Force holds certain fundamental beliefs:

- Deafblindness creates unique needs for individuals with deafblindness and their families;
- Individuals with deafblindness and their families have a right to quality of life reflecting dignity, selfrespect, autonomy, personal choice, and community integration well as the right to the supports that embrace these values; and,
- The community's vision creates the future.

WHO ARE WE?

The Task Force's membership includes individuals with deafblindness, their family members, and representatives from educational and adult service agencies that support individuals with deafblindness.

The Task Force meets monthly to address unmet needs of individuals with deafblindness in our community.
